## **Membership Nomination – Conditions**

### **Eligibility**

The applicant must meet the eligibility criteria for the category of membership applied for, as set out in the Club's Constitution and By-Laws.

### **Completion of Application**

The nomination form must be fully completed and signed by the applicant. Incomplete applications may not be considered.

### **Proposer and Secunder**

Each application must be proposed and seconded by two (2) current financial members of the Club. Applications that do not include both a proposer and a seconder will not be considered.

### **Payment Requirement**

All applications must be accompanied by **full payment of the applicable membership fee and any joining fee, including any pro rata fee where applicable.**

Applications received without payment will not be processed.

### **Pro Rata Membership**

Membership fees may be reduced on a pro rata basis for applications received part way through the membership year, in accordance with a schedule determined by the Committee.

The Committee may vary or waive pro rata arrangements in exceptional circumstances.

### **Committee Approval**

Membership is subject to approval by the Committee.

The Committee reserves the right to accept or reject any application in accordance with the Constitution.

### **No Automatic Entitlement**

Payment of fees does not guarantee acceptance as a member.

If an application is unsuccessful, any fees paid will be refunded.

### **Agreement to Rules and Policies**

By submitting this application, the applicant agrees to be bound by:

- the Club Constitution;
- all By-Laws, policies, and regulations; and
- any lawful directions of the Committee.

### **Code of Conduct**

Members must comply with the Club's Code of Conduct at all times.
